#### VACATION, ADMISSION AND EXAMINATION SCHEDULE IN RESPECT OF COLLEGES IN THE STATE for 2015-16

#### For Semester System(1st year Class).....in phased manner....

The Semester System has been introduced in the Colleges of Himachal Pradesh from the 1<sup>st</sup> year of degree courses from the session 2013-14. In view of this, **the proposed admission/vacation/examination** schedule for the academic session 2015-16 is as under:-

#### Admission Schedule

3.	Open House/ Counseling Sessions/Awareness Sessions	10 <sup>th</sup> June to till the closure of admissions.		
4.	It will be mandatory for every co	ollege to display	time table giving all the details	

about Major/Minor/Elective subjects etc. in the 1<sup>st</sup> week itself after the closure of all admissions i.e. 1<sup>st</sup> July itself, so that the students can choose their minor/elective/GI&II subjects as per the time table and this week will be called as Zero Week.

The regular teaching to classes of 1<sup>st</sup> Semester will commence from 21<sup>st</sup> June in every year. **To achieve 180 days of teaching throughout the year**, the teaching will be for 16 weeks in the 1<sup>st</sup> Semester from the date of regular teaching i.e. 21<sup>st</sup> June onwards. During the 4<sup>th</sup> week (i.e. last week) of October, 10 days will be for Practical Examination and 20 days for Theory Examinations of the 1<sup>st</sup> Semester.

Note:- 1<sup>st</sup> Semester to be of longer duration as to cover Extra Curricular Activities i.e. Sports, Cultural and Elections to student bodies.

<u>Note</u>:- Admission is open for all students on Roll on Basis, who are otherwise eligible without waiting for the final result. <u>Roll on system means the student who has</u> <u>appeared in the 1<sup>st</sup> Semester will go to the 2<sup>nd</sup> Semester as per the schedule without</u> <u>waiting for the result of the 1<sup>st</sup> Semester. However, he/she will have to fulfill all the</u> <u>formalities laid down by the college authorities like filling up of the admission form, if</u> <u>any, and depositing the prescribed fees. This will help to start the regular teaching of</u> 2<sup>nd</sup> Semester in time.

Principal may ensure that there is no provision of admission as per university ordinance after 30<sup>th</sup> June of every year and as per Hon'ble High Court Decision, no admission will be given after the schedule. Principal concerned will be responsible for strict compliance of the admission schedule.
